ITEM 1.01 ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT.

On May 6, 2014, CRFD Research, Inc. (“CRFD”), a Delaware corporation and a wholly owned subsidiary of Marathon Patent Group, Inc. (the “Company”), entered into a patent license agreement (the “CRFD IP Agreement”) with RPX Corporation, a Delaware corporation (“RPX”). The CRFD IP Agreement provides for the licensing of certain patents to RPX at the closing of the transaction.
